In the United States, pesticides are regulated by the U.S. Environmental Protection Agency. There are two basic laws dealing with pesticide regulation: the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), originally passed in 1947, and the Food Quality Protection Act (FQPA), passed by Congress in 1996. FIFRA has been substantially amended over the years. These two laws define how pesticides may be registered, sold, used, transported, stored, and disposed of in the U.S. Additional laws address specific concerns such as safety of pesticide workers (the Worker Protection Standard), protections for endangered species (the Endangered Species Act), and other issues.
